- Programme fees do not include activity & excursion costs (except for English Plus Activities Programme)

* If a student is away from their homestay for 8 nights or more and wishes to return to the same homestay there will be a homestay holding fee charged from the first night away. For absences from the homestay for up to and including 7 nights the full homestay rates apply.

** Fee will apply to the second homestay change following a student's arrival.

***This fee is payable for students staying with a Designated Caregiver. This fee is to reflect the costs incurred by Unique New Zealand in making sure that all students (including those not staying in one of our homestays) are in accommodation which complies with the Education (Pastoral Care of International Students) Code of Practice 2016.

- All fees are in **New Zealand Dollars (NZD)** and include GST(**All taxes**)
- Homestay fees do not include bus fares and spending money
- Homestay weekly fees are calculated based on the student's age on their homestay arrival date. For programmes of more than 4 weeks, the weekly homestay fee changes to the lower rate the week after the student turns 14
- Unique New Zealand matches students with host families based on the information given at the time of enrolment. However, it is not guaranteed all the students' requests will be met, especially during peak seasons
- Internet access is not guaranteed in homestay accommodation and Internet usage may be at the discretion of the homestay family.
- Students are expected to leave their homestays by 5.00 pm on their day of departure. If they want to stay in their homestay past 5.00pm they will be charged for an additional night.
